NOTICE OF PUBLIC HEARING**

The City of Astoria Historic Landmarks Commission will hold a public hearing on Tuesday, July 15, 2014 at 5:15 p.m., in the City Hall Council Chambers, 1095 Duane Street, Astoria. The purpose of the hearing is to consider the following request(s):

1. Exterior Alteration EX14-06 by Michael Nisbett to add a front porch and rear deck, replace garage door with metal rollup panel door with upper lites on an existing single family dwelling at 3525 Harrison (Map T8N-R9W Section 9DB, Tax Lot(s) 11100; Lot(s) 20, Byers Addition) in the R-2, Medium Density Residential zone. Development Code Standards 2.060-2.095, Articles 6 and 9, and Comprehensive Plan Sections CP.005-CP.025, CP.070-CP.075, CP.240-CP.255 and are applicable to the request.
2. Miscellaneous Review MR14-03 by James Defeo, Astoria Coffeehouse to paint a mural on the east elevation of an existing commercial building within the Downtown National Register Historic District at 1084 Commercial (Map T8N-R9W Section 8CB, Tax Lot(s) 8900; Lot(s) 5-6, Block 59, McClure) in the C-4, Central Commercial zone. Development Code Standards 2.425-2.445, Articles 6, 8, and 9, and Comprehensive Plan Sections CP.005-CP.025, CP.050-CP.055, CP.240-CP.255 and are applicable to the request.
3. Exterior Alteration EX14-07 by Monica Hartney, Abode Connections LLC to add 2 windows on 2nd floor south elevation; add one window on 2nd floor dormer north elevation; move paired windows on rear; add double doors & 5' x 10' porch on 1st floor, rear; add double doors & 4' x 7.5' balcony on 2nd floor, rear at 813 14th (Map T8N-R9W Section 8CD, Tax Lot(s) 11401; Lot(s) N. 50' Lots 1, 2, 3, Block 19, Shively) in the R-3, High Density Residential zone. Development Code Standards 2.150-2.185, Articles 6 and 9, and Comprehensive Plan Sections CP.005-CP.025, CP.040-CP.045, and CP.240-CP.255 are applicable to the request.

A copy of the application, all documents and evidence relied upon by the applicant, the staff report, and applicable criteria are available for inspection at no cost and will be provided at reasonable cost. A copy of the staff report will be available at least seven days prior to the hearing and are available for inspection at no cost and will be provided at reasonable cost. All such documents and information are available at the Community Development Department at 1095 Duane Street, Astoria. If additional documents or evidence are provided in support of the application, any party shall be entitled to a continuance of the hearing. The location of the hearing is accessible to the handicapped. An interpreter for the hearing impaired may be requested under the terms of ORS 192.630 by contacting the Community Development Department at 503-338-5183 48 hours prior to the meeting.

All interested persons are invited to express their opinion for or against the request(s) at the hearing or by letter addressed to the Historic Landmarks Commission, 1095 Duane St., Astoria OR 97103. Testimony and evidence must be directed toward the applicable criteria identified above or other criteria of the Comprehensive Plan or land use regulation which you believe

apply to the decision. Failure to raise an issue with sufficient specificity to afford the Historic Landmarks Commission and the parties an opportunity to respond to the issue precludes an appeal based on that issue.

The Historic Landmarks Commission's ruling may be appealed to the City Council by the applicant, a party to the hearing, or by a party who responded in writing, by filing a Notice of Appeal within 15 days after the Historic Landmarks Commission's decision is mailed. Appellants should contact the Community Development Department concerning specific procedures for filing an appeal with the City. If an appeal is not filed with the City within the 15 day period, the decision of the Historic Landmarks Commission shall be final.

The public hearing, as conducted by the Historic Landmarks Commission, will include a review of the application and presentation of the staff report, opportunity for presentations by the applicant and those in favor of the request, those in opposition to the request, and deliberation and decision by the Historic Landmarks Commission. The Historic Landmarks Commission reserves the right to modify the proposal or to continue the hearing to another date and time. If the hearing is continued, no further public notice will be provided.
