### NOTICE OF PUBLIC HEARING

The City of Astoria DESIGN REVIEW COMMISSION will hold a public hearing on **Thursday, February 6, 2025** at 5:30 p.m., at Astoria City Hall, Council Chambers, 1095 Duane Street, Astoria. The purpose of the hearing is to consider the following request:

Design Review Request (DR24-02) by Columbia River Maritime Museum ("CRMM") to install 21 signs at 852 sqft for CRMM campus at 1792 Marine, 1840 Marine, and 2040 Marine Drive (Map T8N R9W Section 8DB, Tax Lots 101, 102, 200, 202, 203, 201, 301, 401, 402, 1100, 1200; Map T8N R9W Section 8DA, Tax Lots 201, 202, 204, 700, 2201). Development Code Sections 2.809 to 2.902 (MH Zone), 14.005 to 14.030 (GO Zone), 14.035 to 14.075 (CGO Zone), 6.020, Articles 8 (Signs), 9 (Administrative), 12 (Variances), and Comprehensive Plan Sections CP.057 to CP.058 (GO Area), CP.067 to CP.068 (Riverfront Vision Overlay Area), and CP.260 to CP.275 (Parks, Recreation, Open Space), are applicable to the request.

A copy of the application, all documents and evidence relied upon by the applicant, the staff report (published seven days prior to the hearing), and applicable criteria, are available for inspection at no cost and will be provided at reasonable cost. All such documents and information are available by contacting the Community Development Department by mail at 1095 Duane Street, Astoria, OR 97103, by email at [planning@astoria.gov](mailto:planning@astoria.gov) or by phone at (503) 338-5183.

The location of the hearing is accessible to the handicapped. An interpreter for the hearing impaired may be requested under the terms of ORS 192.630 by contacting the Community Development Department 48 hours prior to the meeting at (503) 338-5183.

All interested persons are invited to express their opinion for or against the request(s) at the hearing, or by letter addressed to the Design Review Commission, 1095 Duane St., Astoria OR 97103. Email transmissions may be sent to [planning@astoria.gov](mailto:planning@astoria.gov). Testimony and evidence must be directed toward the applicable criteria identified above or other criteria of the Comprehensive Plan or land use regulation which you believe apply to the decision. Failure to raise an issue with sufficient specificity to afford the Design Review Commission and the parties an opportunity to respond to the issue precludes an appeal based on that issue.

The public hearing, as conducted by the Design Review Commission, will include a review of the application and presentation of the staff report, opportunity for presentations by the applicant and those in favor of the request, those in opposition to the request, deliberation and decision by the Design Review Commission. The Design Review Commission reserves the right to modify the proposal or to continue the hearing to another date and time. If the hearing is continued, no further public notice will be provided.

The Design Review Commission's ruling may be appealed to the City Council by the applicant, a party to the hearing, or by a party who responded in writing, by filing a Notice of Appeal within 15 days after the Design Review Commission's decision is mailed. Appellants should contact the Community Development Department concerning specific procedures for filing an appeal with the City. If an appeal is not filed with the City within the 15-day period, the decision of the Design Review Commission shall be final.
