For Fiscal Year Beginning July 1, 2024

The City of Astoria established the Arts and Cultural Program to provide funding to art and cultural events that will increase tourism in the City. Grant funding is provided through the Promote Astoria Fund which receives its funding from Transient Lodging taxes. The City will make available an amount not to exceed \$100,000 for distribution in the fiscal year beginning on July 1, 2024. The actual amount of funding will depend on resources available, and will be finalized during the annual budget process. Awards will not be final until the 2024-2025 Fiscal Year Budget is adopted by the City Council in June 2024.
