

ORDINANCE NO. O 55-29

INTRODUCED BY COMMISSIONER ERIC HAUKE

AN ORDINANCE PROVIDING FOR UNIFORM NUMBERING OF BUILDINGS AND DWELLINGS IN THE CITY OF ASTORIA, OREGON ADOPTING THE MAP AND PLAT OF STREETS AND ALL HIGHWAYS ON FILE IN THE OFFICE OF THE CITY ENGINEER, PRESCRIBING CERTAIN DUTIES OF THE BUILDING INSPECTOR OF THE CITY OF ASTORIA, AND PROVIDING PENALTY FOR VIOLATIONS, AND PRESCRIBING EFFECTIVE DATE OF THIS ORDINANCE, AND REPEALING ORDINANCE NUMBER 5489 PASSED JUNE 4, 1919.

BE IT ORDAINED BY THE CITY OF ASTORIA:

SECTION 1. There is hereby provided and adopted a revised uniform system of numbering of buildings and dwellings within the City limits of the City of Astoria.

The numbers with holders shall be conspicuously placed immediately above, on or at the side of the proper door of each building so that the number can be seen plainly from the street line. Whenever any building is situated more than fifty feet from the street line, the numbers and holders shall be placed near the walk, driveway or common entrance to such building and upon a gate post, fence, tree, post, or other appropriate place so as to be easily discernible from the sidewalk.

Such numbers with holders shall be of the type, size and character as adopted by action of the City Council.

SECTION 2. Odd numbers shall be given to buildings and dwellings on the West and South sides of the streets, avenues and highways, and even numbers to those on the North and East side of the same. The exception being streets which reverse themselves in direction.

SECTION 3. The Building Inspector of the City of Astoria shall designate the numbers of all buildings and dwellings in conformity with the plat of streets now on file in the office of the City Engineer of the City of Astoria. The Building Inspector shall furnish the number of each building or dwelling now or hereafter erected with its proper number.

All existing numbers of property and buildings not now in conformity with provisions of this Ordinance shall be changed to conform to the system herein adopted within three months from the passage of this Ordinance. The numbers with holders shall be furnished through the office or under the supervision of the Building Inspector at cost thereof. Numbers with holders shall be placed on buildings and dwellings hereafter erected immediately upon completion thereof and before occupancy.

SECTION 4. That Ordinance No. 5489 heretofore passed as of June 4, 1919 is hereby repealed.

SECTION 5. In case any owner shall fail or refuse to place or attach numbers with holders on any building or dwelling as herein required, he shall be deemed guilty of a misdemeanor and, upon conviction thereof in the Municipal Court of the City of Astoria, may be punished by a fine of not less than five (5) nor more than ten (10) dollars for each day's refusal or neglect, or by imprisonment in the City Jail not to exceed one (1) day for each two dollars (\$2.00) of the fine so
